



TACR Corporate Renewal of the Year 2011-12 Nomination Form

Eligible Nominees

- Anyone may nominate a person who or firm which has been a TACR member for all of 2011 to receive this award. Self-nominations will be accepted.

General Award Criteria

- This award may, at the discretion of the Award Selection Committee, be given to a person or entity responsible for the renewal of a company that was in serious financial distress and at the end of the renewal process was, in some form, operating successfully (including a sale of the company as a going concern). The Small Business (annual revenues less than \$25 million) and Large Business (annual revenues greater than \$25 million) Corporate Renewal of the Year Award may be given for corporate renewal of a business of that revenue range.
- The corporate renewal must have been completed after January 1, 2011.

Nomination Information

No confidential information may be provided to the Award Selection Committee unless the Committee has provided its prior written consent.

- Entry Form and Initial Summary (See attached)
 - Name and contact information of nominating person.
 - Name and contact information of person or firm being nominated.
 - Designate nomination as either 1) Small (less than \$25 million annual revenue) or 2) Large (greater than \$25 million annual revenue) corporate renewal.
 - A brief (approx. 1-3 pgs.) summary description of the renewal process, which *shall not include confidential information*.
- Supplemental Information – The Award Selection Committee *may* request additional (written or verbal) information from the nominating person, including (without limitation) further detail regarding:
 - Financial information concerning the company at the beginning of the corporate renewal process.
 - The nominee practitioner's or firm's actions which led to the successful corporate renewal.
 - Financial information showing the results of the corporate renewal.

Nomination Deadline

Review Process

- TACR will advise each nominating person that the Initial Summary has been received. Any award recipient will be notified, in writing, by TACR.

Award Presentation

- If a Small or Large Business Corporate Renewal of the Year for 2011 is selected, the award will be presented at the regular TACR educational meeting around March 2012.
